The Kokomo Quarter Midget Club (KQMC) is proud to offer the use of this race-ready quarter midget to a selected family for the 2019 KQMC racing season!

TERMS OF AGREEMENT WITH KQMC

- 1) Recipient must join KQMC as a full member and comply with all membership requirements, including club dues and weekly entry fees and duties.
- 2) Recipient must join USAC and comply with all membership requirements, including annual dues and insurance fees.
- 3) Recipient is responsible for the purchase of approved safety equipment for the driver (helmet, gloves, suit, arm restraints, neck restraints, Raceceiver and ear buds).
- 4) Recipient must be able to transport the car to and from the track for events securely, and must be able to provide secure, enclosed storage.
- 5) Recipient will be awarded the use of a race-ready quarter midget for the 2019 racing season.
- 6) Recipient must pay a \$200 refundable deposit upon receipt of the car. Deposit will not be refunded if the car is not returned in its original condition by November 1, 2019.
- 7) Recipient is responsible for weekly maintenance of the car, such as oil changes and cleaning. Failure to comply will result in forfeiture of deposit.
- 8) Recipient is responsible for replacing any bent or broken parts incurred during the racing season (radius rods, nerf bars, worn out tires, etc). Failure to comply will result in forfeiture of deposit.
- 9) No alterations or changes to the paint and decaling of the car is permitted. Paint and decals are to be maintained in original condition.
- 10) Car is to be used initially in the rookie class. With approval of the KQMC board the car may be used in progressive classes.
- 11) Recipient must agree to participate in at least 75% of KQMC club races in the 2019 season. The car may be used in State Series and Midwest Thunder events held at KQMC and Mini-Indy Speedway (CIQMA). The car may not be used in any other events without Board approval.
- 12) Recipient must agree to bring the car to and assist with all Arrive and Drive and promotional events held at KQMC. Recipient will NOT be responsible for any damages incurred at arrive and drive events.
- 13) Missing 3 consecutive events will revoke this agreement. The car will be returned to KQMC. Failure to comply will result in forfeiture of deposit.
- 14) Recipient is responsible for any medical injuries incurred during participation and should have medical insurance for the driver.
- 15) KQMC reserves the right to revoke this agreement for any reason and pursue necessary means to ensure the return of all KQMC property.
